

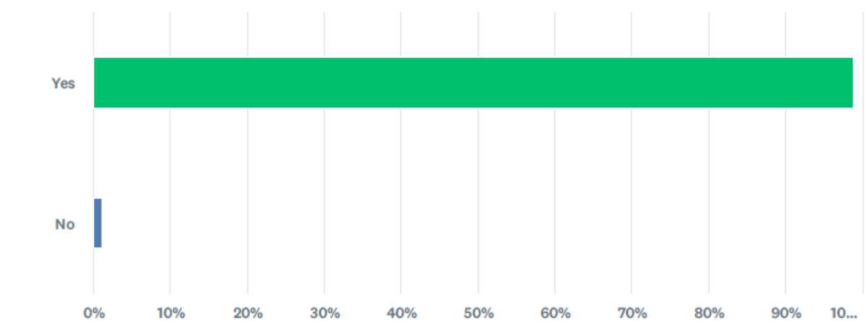
# Precept Consultation 2026/27

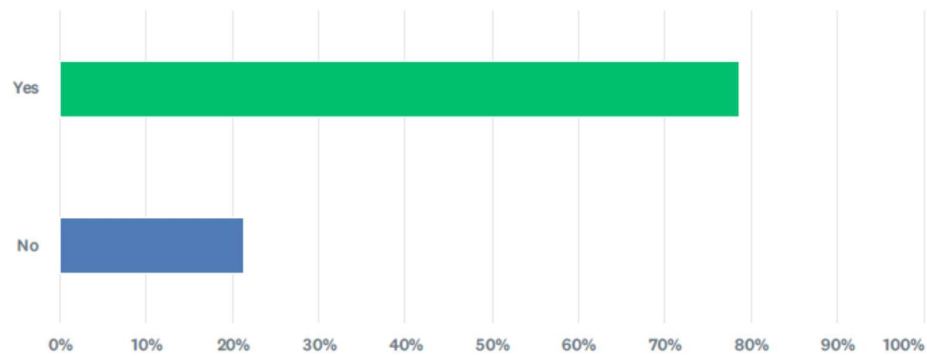

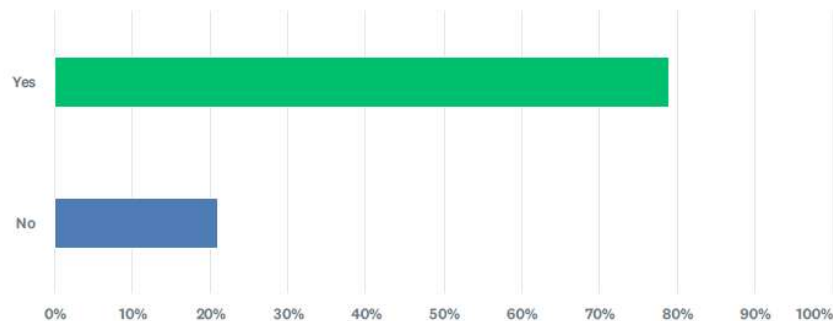
