#### **About our plan**

Fires and emergencies affect peoples lives in a big way.



All fire and rescue services must have a plan that says:



how we will work

#### and

how we will try to have less risk of fires and emergencies



**Risk** means there is a chance that something could happen.



Fires and emergencies are not just things like fires and car crashes.



It could also be things that happen less often like:

floods



 terrorist attacks. A terrorist is a person who uses force or violence to scare other people



a building that has fallen down



We can have less risk of fires and emergencies by:

changing the way we work



 working together with other services and organisations



 using our staff and resources in the best way. Resources means things like our buildings and fire engines



 teaching people about the risks of fire and emergencies and how to deal with them



supporting people who need our help



 making sure people follow the law about fire safety



#### PART 1: How we will work

We have a set of rules we have to follow in our work.



# 1. Help to stop fires and emergencies from happening in the first place

We will work with our local communities. We will tell people what can cause fires and emergencies and how they can stay safe.



We will make sure our services are easy and fair for everyone to use.



### 2. Make sure organisations follow the law

They must make sure their buildings are safe for people to use.

# 3. Make sure our staff have the training they need to do well in their jobs



We will make sure our buildings are close to our communities.

This will help our staff get to fires and emergencies as fast as possible



# 4. We will work together with other services and organisations in our communities

For example the police or ambulance services.



We will help people to cope better when fires or emergencies happen.



### 5. Make sure we spend money in the best way

This means we can keep giving good services that our communities need.



Part of this is making sure we work in a way that is good for the **environment**.

The **environment** is the world we live in and the air we breathe.



### 6. Make sure we are a friendly, safe place to work

We will make sure the people who work for us are from different parts of the our community.

# PART 2: How we will try to have less risk

There are 6 big things we want to do in the next 4 years.



### 1. Write a new plan to help us deal with changes in Berkshire

There are changes happening that mean more risks to people. Our new plan will help us manage these risks.



#### Changes we are dealing with:

#### Climate change

The world is getting warmer which means changes in our weather. We call this **climate change**.



In summer 2022 the UK got really hot. There were lots more fires across Berkshire.



We are getting more rain in winter. This means more floods and people who have to be rescued.



#### **Using energy**

We use **energy** to make things work. Things like gas and electricity.



People are using energy in different ways. Things like:

 using green energy to heat their homes.

**Green energy** means using energy from the sun or wind. Things like solar panels on a building or a wind turbine in a field



 charging more devices like phones and computers



 using electric chargers to charge electric cars



These all mean more risk of fires and emergencies.



We will make sure people in our communities know about these new risks and how to manage them.



We will check our plan every year. We will see if there are any changes we need to make.

# 2. Make sure we work with people who are the most at risk of having an emergency

We are going to find out which people are most at risk in our communities.



This means we will be able to work with people earlier to help them stop emergencies happening.



We will work with our local council and other organisations to find out who is most at risk.



This could be people with a learning disability or older people who need extra support.

# 3. Make sure we spend our money in the best way

We understand that our money comes from local people. We have to spend it in the best way.



We have to make sure that we spend money on the most important things.



We will make sure that we have enough staff and special fire engines to deal with emergencies.



When an emergency happens, people ring **999** and they send the closest fire engine.



We try to get to the emergency within 10 minutes. We want this to happen in at least 7 out of 10 emergencies.

4. Look at all of the emergencies we went to. We will think about whether we have to stop going to some types of emergencies

We have a list of emergencies that we must go to. These are called our statutory responsibilities.



The list includes things like putting out fires and rescuing people after a car crash.



Sometimes we get called out for other things that are not on the list. For example, to rescue an animal.



We will work with other services and organisations to look at the best way of dealing with these things.



This means we will have more time to deal with the most important emergencies.

# 5. Support for businesses and new buildings

Our Fire Protection service sends staff to check buildings are safe for people to use.



### Making sure people follow the Fire Safety law

We will make sure Fire Protection staff go to buildings that are at the most risk.



Staff will talk to local people about the Fire Safety law. And they will make sure people know how to keep themselves safe.



#### Making sure new buildings are safe

When people build houses they have to follow building laws.



We will work with local builders and the council. We will make sure new buildings are safe and follow the building laws.



#### False alarms

A **false alarm** is when we get called out to an emergency but there isn't one.



We will try to have less **false alarms**.



Some buildings have alarms that automatically call the fire service.

Sometimes these alarms go off by mistake.



We want to work with people who own buildings about fire safety and having less false alarms.



#### **Sprinkler systems**

A **sprinkler system** is when water comes out of pipes on the ceiling to stop a fire.



We want more **sprinkler systems** in buildings.

# 6. Every day we need at least 14 fire engines to use in emergencies. We will make sure our staff use these in the best way



We have 19 fire engines. We also have other vehicles that we can use in emergencies.

We will try to have staff on all of our 19 fire engines.



There are some times when we do not have enough staff for all the vehicles. For example if staff are off work sick.



If this happens, we will try to make sure we have staff on at least 14 fire engines.



This will help to make sure we can get to fires and emergencies as quickly as possible.


